Fundraising and Property News

The facilities committee of ACPE which I have been chairing reported to the board that we had secured the \$1 million dollars needed to purchase 540 Church Street as the new home for ACPE, its academy and possibly some of the other cognate groups. It was a great effort by ACPE leadership, FCPE leadership and some very generous, determined donors. The report to the board was met with a standing ovation. Congratulations to all who worked so hard to make this dream come true!

What this means is that we now have entered a Capital Campaign of \$11 million dollars to build a new building on the site and have an endowment that will help with upkeep. The existing building on the site was not salvageable. The city of Decatur and people in the area are excited at the prospect of a special building emerging in the center of the city.

HOSPITAL CHAPLAINS NOT REQUIRED TO KEEP INFORMATION PRIVATE

It seems a reasonable supposition, that things said in confidence to a minister are between you, the minister and God.

Not so if you're talking to a hospital chaplain. Depending on the hospital, what you tell a chaplain could be included in your - or a family member's - medical record.

Dayna Leichty of Little York, Illinois, learned this in March while her 10-month-old son was receiving treatment at the University of Iowa Hospitals and Clinics. There, she was visited by a hospital chaplain.

"We just chatted as a lot of people would with someone from the spiritual department," said Leichty. "You expect that you can trust them, you expect that they might be there for comfort, for support, for

prayer, so we welcomed them in."

Leichty told the chaplain a variety of things she had thought would be kept confidential, including that she was pregnant.

"I mentioned things about my own health," explained Leichty. "Things about my own opinions and past."

Soon after, a UIHC medical staff member approached Leichty and asked her about being pregnant.

"Then it turns out that it was all written down in my son's medical history, medical chart and it had nothing to do with his health," she said. "It just wasn't anybody's business."

Leichty immediately began trying to get the chaplain's note removed from her son's medical record. It took a week of phone calls and the assistance of the Patient Relations Office.

Since 1996, UIHC chaplains have documented information exchanged in a conversation between a hospital chaplain and a patient.

"The information gathered during pastoral conversations and the care offered to patients/families frequently is of value to other members of the treatment team", according to a statement provided by UIHC spokesman Tom Moore concerning general spiritual care services policy.

Hospital chaplains are actually required by the Joint Commission, an accreditation organization for hospitals, to document information learned while visiting a patient, said Mark McDermott, former director of pastoral care at Mercy Iowa City and now at Mercy Medical Center in Cedar Rapids.

"If they ever came and saw a chaplain on a unit, they would ask 'Did you document that visit, that's very important," explained McDermott. "If it wasn't documented, then it wasn't done."

Leichty was upset, though, because she was not informed that what she told the chaplain would be documented and placed in her son's medical record.

UIHC hospital chaplains are not required to "notify patients or families what information they provide will be noted in the medical record," said Moore. Leichty believes the policy is flawed.

"I feel like I can speak for many people that when someone comes in representing the clergy or representing a religion that it's going to be something that you can trust will be confidential, but it turns out conversations are only confidential if they're started with 'Father, I have a confession,'" said Leichty.

Moore said UIHC makes exceptions for the sacrament of reconciliation.

Other Eastern Iowan hospitals including St. Luke's and Mercy Medical Center in Cedar Rapids and Mercy in Iowa City offer spiritual services.

Their policies are not as stringent as the UIHC's, though. Mercy Medical Center's McDermott said if a patient or a family member asked him to keep certain information not relevant to the patient's treatment plan confidential, he would respect that. He would have done the same at Iowa City.

"Things that come up like that all of the time," said McDermott. "I would be discreet."

St. Luke's chaplains also have discretion in what they document about a patient visit and they inform patients that information is documented and added to records.

Chaplains are "encouraged to share with the patient what they may include in the patient's medical record, and in doing so, with other members of the treatment team," St. Luke's spokeswoman Sarah Corizzo said.

Leichty hopes that hospitals will re-examine their spiritual care policies to better inform patients.

"Just a little disclosure to say, 'We view our clergy as one of the medical team...and conversations with them will be part of the medical chart,'" Leichty said, "Easy as that."
