Driving on the Reserve Tank

I read the other day about a man who, when he buys a new vehicle, immediately puts a five gallon container of gasoline in the trunk and drives the car until the gas tank runs dry. Then he puts in the five gallons of gasoline and proceeds to the nearest station and fills up. From this he learns several things: How many miles will the car go on a tank; how many miles will it go after the low fuel warning light comes on; and is it really empty when the needle points to "E", or is there still a little fuel left. I have never performed this exercise myself, but I have, on several occasions, wished that I had. I have been out in the middle of nowhere in the middle of the night with the needle on empty, or the warning light burning, and wondered how far my car will carry me before it is actually, completely out of gas. Mostly, like many of you, I suspect, it is my practice to put fuel in my car long before it reaches that point. This is because I do not like to live without a safety net. Although my car has a low-fuel warning light, I vigorously avoid getting that low on reserves.

I think this is a good habit on my part, and it is reflective of the way I live my life and do my work. For example, I tend to pay bills when they arrive, not the day they are due; I like to have my responsibilities at work completed before the deadline, and I always want to have a back-up plan in place if things go wrong. Having a back-up plan is like having a reserve tank in your vehicle. If, for some reason, you run out of gas in your main tank, you can switch to the reserve and hopefully, get to your destination.

I am currently in just such a situation. The supervisor in training with whom I am working was due to start a unit of CPE with a new group of students this week. He is a native of a country in West Africa, and went home to take care of some pressing responsibilities before the unit began. When the time came to return to the United States (just in time to start his CPE program), he was detained by the government, causing him to still be in Africa when the unit was starting. So when I arrived at work on Monday morning, I found myself in charge of a CPE program that I was not planning to supervise. I had been monitoring preparations the supervisor in training had been making, and knew a good bit about it. I had his schedule, which was helpful, but incomplete, and I was aware of most of the people he had recruited to meet with his students, but found there were some surprises—things that had to be "fixed" at the last minute. I described my feelings to my colleagues by using a metaphor that I heard years ago, being used about the increasing tempo of change in the world. I said I felt like the train was speeding down the track ninety miles an hour, but I was out ahead of the train just a hundred yards trying to lay new track before the train ran out of rails.

This seems to me to be an example of a CPE program, which has been forced to run on the reserve tank. It is an uncomfortable position to be in, but it is also informative. I am learning that the reserve tank is not only there, but it is bigger than I realized, and contains some very high quality gasoline. I will step out of the metaphor for a moment and say it plainly. This experience of putting together a week of orientation for a new CPE group hour by hour, staying just ahead of the students has revealed to me the wonderful richness of the resources in our center, and the cheerful cooperation and goodwill of so many colleagues and staff persons in the hospital system where I work. When I contacted people at the last moment and laid out honestly and simply the dilemma I faced in getting this group prepared for their clinical experience, I was gratified to see the spirit of cooperation and support that these folks demonstrated in sharing my load. At this moment, we have made it through four days of orientation. As I write, the students are out on nursing units, shadowing nurses to learn something of how the world looks to the hospital staff. This is happening because when I requested this cooperation from three overworked Charge Nurses this morning, they agreed without hesitation, to each take two of my students.

What I take from this experience is that although I try to avoid getting in to my reserve tank, it is good to know that when necessary, it is there. I also realized that when I am forced to this extremity I have some very delightful interactions with professional colleagues who make me proud by the dedication and helpful spirit they display. These are demonstrations of the support and back up available to us that we would never fully appreciate if we didn't occasionally have to drive on the reserve tank.
