CAN YOU BELIEVE. . .

Whenever I have conversations with Judy Ragsdale they are interesting; two of my comments are in response to some of her questions.

Recently, I have been helping people with their theory papers either as a consultant, supervisor, or reader. A list of do's and don'ts for writing theory papers began to form. Here's a beginning list, please add to it or respond to it and I'll include it in the next newsletter.

THE DO'S AND DON'TS OF WRITING THEORY PAPERS

1. *Remember these are graduate level papers.*
2. *Read the questions directing each paper and respond to the question(s).*
3. *You need to be an expert in the theories you are writing.*
4. *Therefore, do not use derivative writings on the theorist.*
5. *Select a theorist that closely matches your experience.*
6. *Be able to critique your theory and understand its limitations.*
7. *Know the general field in which you are writing.*
8. *Demonstrate inclusivity and appreciation for diversity.*
9. *There is never just one way of doing something.*
10. *If you can't write have someone teach you.*
11. *If you can't edit have someone edit for you.*

Some general impressions: If your papers are poorly written they won't pass. Get several opinions on how well they're written. The biggest problem I've seen recently is that people turn in their papers without answering the questions. The readers are using the areas the questions come from to evaluate the papers.

Judy said, "Tell me again why we are doing the new building in Decatur." I'll try.

During Joan Hemenway's presidency, in 2006, I was asked to serve on a task force to implement some of the strategic plan that ACPE was working on. Art Schmidt continued to work with the task force after Joan's illness and death. Members of the task force included: Art, Deryck Durston, John Moody and others. We looked at the goals of the plan, addressed fundraising and potential building.

The organization generally recognized that we had out grown our building and if we wanted to remain the premier training program we would need to do something to address the problem. At the same time, our international programs were growing, requests for distant learning and our need to offer continuing education for supervisors and others was increasing.

The idea that became the ACPE Academy came out of those discussions.

We did some preliminary investigation into our ability to fundraise and were amazed at the potential resources of the members of our organization.

We believed we could design and construct a building that we would be proud of, that would include meeting space, educational technology and would improve service to the organization.

The task force reported to the ACPE board at least 5 times in the next few years and received encouragement to keep working.

Fundraising for the building, the creation of FCPE and most importantly trying to change the culture of the organization has been both interesting and tumultuous.

At times, we are a strangely modest group. We are ministers after all and there seems to be an aversion to thinking too highly of ourselves at least when it comes to financial matters.

However, the vision for a sustainable future for this organization and its important role in the international family is bigger than either our arrogance or modesty. As always I welcome your reactions.

Chaplains in Scotland to Pilot an Effectiveness Questionnaire

A brief chaplaincy effectiveness questionnaire is being readied to pilot at the Royal Infirmary of Edinburgh and other hospitals under the auspices of the National Health Service Education for Scotland and Mowat Research, according to Chaplain Iain Telfer and Dr. Harriet Mowat. The project is intended to develop and test patient-related outcome measures (PROMS). The PROMS questionnaire is completely congruent with the next step in the Ideal Intervention Project (IIP) research design toward testing and validating evidence based spiritual care best practices. Please stand by for information about possible comparative work in the U.S. later in the year.

Excerpts from the Editor's June 27 Open Letter to COMISS Network Leaders

“Dear Colleagues: ...In the near future U.S. health care professionals, including chaplains and clinical pastoral educators, will increasingly be paid only by demonstrating the achievement of evidence based best practices desired outcomes. ...Failing to demonstrate the ability to achieve evidence based best practices desired outcomes, chaplains and clinical pastoral educators will increasingly be replaced with local religious volunteers.”

Reasons for this troubling forecast: “U.S. health care costs continue to spiral upward. Pay-per-performance systems are on the increase. The Patient Protection and Affordable Care Act is being implemented. Other countries’ chaplaincies are setting the pace by moving toward pay-for-results.”

Action steps: “Make a professional commitment to vigorously advocate for the Ideal Intervention Project among your constituents... Contribute to the spiritual care knowledge base... Secure institutional commitment and support... Apply IIP learnings now...”

THE IDEAL INTERVENTION PAPER

Write the IIP in such a way that you or another chaplain could make a more effective intervention with patients, families or staff with similar spiritual/pastoral needs. Do not address your learning issues. The IIP should be prepared as a Word document suitable for forwarding as an e-mail attachment, and should include the following elements. Copy your supervisor with the forwarding cover e-mail message as evidence of your IIP submission to the national knowledge base editor.

Ideal Intervention Form

(For Use by All Spiritual Care Practitioners and CPE Students)

1. Statement of the Spiritual/Pastoral Care Central Issue (e.g., Feeling Angry and Abandoned by God; Hope in Terminal Illness, etc.)

2. Narrative Summary of the Actual Spiritual/Pastoral Care Intervention (No more than two paragraphs of narrative description. Take confidentiality precautions.)

3. Narrative Summary of the Ideal Spiritual/Pastoral Care Intervention (No more than two paragraphs of narrative description of how you would do the intervention differently if given another opportunity. Write so that another practitioner with a similar situation could benefit from your insights.)

4. Resources that you would recommend to other spiritual care givers regarding this topic. (Books, journal articles, pamphlets, etc.)

5. Forward a copy of this completed form to Knowledge Base Editor John Gleason at mariejohn50@att.net as a Microsoft Word attachment for inclusion with similar data toward validating evidence based SC best practices. Confidentiality precautions will be taken. You will be asked to approve the edited version before entry in the SC knowledge base. Thanks for your contribution!
